I. Course Description

What is good? Why be good? Upon what basis can these questions be answered? Historically how have thinkers attempted to answer these questions? This course will deal with these essential issues, examining basic moral theories and contemporary issues comparatively interpreted in light of these systems.

II. Course Objectives

1. To consider the gravity of ethical grounding and moral disagreement
2. To gain an understanding of basic moral theories and areas of agreement and disagreement between them
3. To become conversant in applying basic moral theories to contemporary issues

IV. Evaluation of Student Performance
